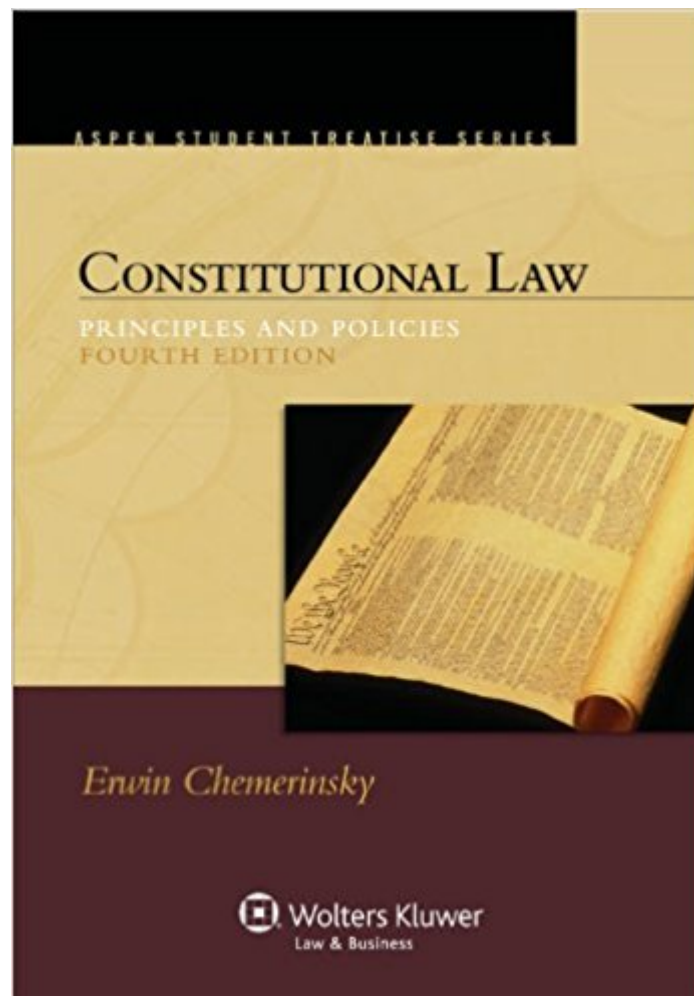

Chamerinsky sets the standard for constitutional law course supplementation. He distills the most opaque cases and makes entire doctrines accessible to first year students. This treatise is a must-have for all law students.

No supplement could possibly compare with the comprehensive coverage Chimerinsky gives Constitutional law in this book. This is good for Con Law I and Con Law II. Enough cannot be said about how valuable this supplement is. Also, this is about the lowest price you can find them. So this should be your final destination in your Con Law supplement shopping.

Chemerinsky is truly the con law God. All hail, Chemerinsky. But in all seriousness, if I could give this 6 stars I would. My con law class used Chemerinsky's casebook, which is a huge book, so it was just a monster to try and wrap my head around. This treatise really broke everything down nicely and in a more understandable manner. This combined with the casenote legal briefs tied to Chemerinsky's casebook saved me from the hell that is con law. Highly, highly, highly, highly recommended.

You should buy this book, simply because it's a good supplement and the best con law book, but it won't be all that helpful, unfortunately. I would just use the library copy or borrow it from a friend, or simply make a list of the ten items you have questions about and corner your con law professor for an hour and make him/her explain everything.

Chemerinsky conducts a thorough, well-explained, well-laid out, and accessible examination of the Constitutional Law subject matter. His book explains almost every case from my case book (Tushnet, Karlan), lays out the policy reasonings, and philosophical debates in an easy-to-read AND easy-to-understand way. The only thing that would make this book better would be an outline that goes along with it.
