

I didn't choose to buy this book, rather it was required for my Evidence course. I would seriously recommend buying the reading companion from the publisher, the book does not do a great job of explaining the basics of the rules. For instance the section of Character evidence gives a lot of information about how Character evidence has been interpreted in modern law, however there is

little simple explanation of what Character Evidence is in minimal detail. In other words the book dives deep into the nitty gritty of subject matter w/o giving the reader a basic understanding of what they have just jumped into. If you made it this far through my review, I hope you have found it helpful.

This casebook contains cases, notes, materials, and other examples regarding evidence and its general rules. Evidence is one of those subjects that combines black letter law with theory. This text provides factual cases and examples of specific, and interesting situations in which evidence can or may be introduced. This text is ideal for any law student or person wishing to broaden their knowledge on the rules of evidence. This text also contains the California Evidence Code and The Federal Rules of Evidence in the back. Even though this is yet again another expensive and possibly over-priced textbook, the cases and information inside is truly helpful.

Very poorly written book! This is a very interesting subject and I was excited to read the book, but it is very difficult to follow because of how poorly written it is. There are multiple typos and a lot of unnecessary words that makes reading more confusing and complicated than it should be. For example, on pg. 85-86, the author interchangeably uses two names in a hypothetical which makes it extremely difficult to follow. On top of that, there is a typo on pg. 85. Avoid this book if you have the choice.

A bit extraneous and disorganized, but gets the job done. There's extra material from Shakespeare and other literary works to illustrate the intuitive/common-sense notions that underlie evidentiary rules. The book also has a tendency to dump a bunch of cases on a particular rule without adding any further understanding to the rule's application. Other than that, the book is okay...

I'm not sure "love it" is the right description for a case book; however, this book was well packaged, well delivered, and as described. The book itself really is a great book for an evidence class.
